Established in 1993, Bristow Manor Golf Club exudes colonial charm combined with some of the best course conditioning in Northern Virginia. With its luxuriously plush Zoysia-grass fairways, bent greens, and the signature 467-yard seventh hole — a par 4 locally voted as one of the Top Ten Toughest Holes in Northern Virginia — Bristow Manor Golf Club has established itself as the D.C. area’s premier daily fee course.

Located just thirty-five minutes outside of Washington D.C. amid the rolling terrain of Bristow, Virginia, this Par 72 Championship Golf Course tops out at 7,102 yards with generous fairways, undulating greens, and a picturesque eighteenth hole framed by a bunker and a pond, with the stunning Manor House as its backdrop. The USGA rated the course 73.9 from the Back Tees, with a slope of 141. Bring your A-Game, or step back to one of our more forgiving Tees, so you can take advantage of the wide landing areas without forced carries.

Deposits & Policies

DEPOSIT SCHEDULE AND CANCELLATION

A non-refundable deposit of \$500.00 is due along with a signed contract to secure a date. Final guest count and payment is due one week prior to your event date. Additional charges incurred during the event such as consumption bar charges must be paid at the conclusion of the event.

GOLFER COUNT

Additional participants or guest (non-golfer) meals may incur additional fees. A golfer and volunteer count as well as additional guests are required no less than seven days prior to the event date. A list of pairings and handicaps is requested three days prior to the event with the understanding that minor changes may occur.

GOLF CARTS

The outing assumes all responsibility and liability for and indemnifies and holds Bristow Manor Golf Club harmless from and against, any and all damage to golf cart, course or adjoining properties, and injury to persons, which is related to, or caused by, the undersigned (or undersigned's guests') use of the golf cart or play on the course.

FOOD AND BEVERAGE & FACILITY POLICIES

All food and beverage service for your event must be coordinated by Bristow Manor Golf Club. No outside food or beverage is permitted. The Outing is responsible for its guests' compliance with all "Facility Policies."

INCLEMENT WEATHER

Should inclement weather prevail on any scheduled day of play, Bristow Manor Golf Club reserves the right to either open or close the course based upon the recommendation of the acting Superintendent and/or General Manager. If the course is deemed "open," groups will be charged as contracted. If the course is deemed "closed," the outing may be rescheduled within 90 days. In the case of "Discontinued Play" in which the course is first deemed "open" and is later "closed" due to inclement weather, all charges will apply, and a rain check credit will be issued to golf participants based on golf rate and number of holes completed. Bristow Manor will move forward with Food & Beverage meals unless otherwise instructed by the Outing.

Directions

From I-95 South | Take Exit 152, Route 234 North. Proceed approximately 8.5 miles and turn left onto Route 619 West, Bristow Road. Proceed approximately 8 miles and turn left onto Valley View Drive. Club's entrance will be on the left.

From I-66 West | Take Exit 44, Route 234 South. Proceed approximately 4 miles, exit onto Route 28 South, Nokesville Road. Follow approximately 2 miles and turn left at signal onto Bristow Road. Proceed approximately 1.5 miles and turn right onto Valley View Drive. Club's entrance will be on the left.
